

6/16/23 EVPC Board and Foundation Joint Meeting YMCA

The joint meeting was scheduled by Roger Schaljo during the 5/1/23 EVPC Board meeting. Minutes from the 6/4/23 Annual meeting were approved via email on 6/12/23.

EVPC BOARD MORNING MEETING:

EVPC Board Members present: President, Roger Schaljo; Vice President Bob Block; Treasurer Maureen McCauley; Secretary Christine Payne; Jeff Seldon, Garret Gilchrist, Chris Achtien. Derek Jensen was present for a portion of the meeting. Bryan Baugnon was unable to attend.

1) Review of committee Goals and Responsibilities Roger discussed the goals that came out of the first Club meeting 6 years ago and how the name of the Club came about. About 30 people attended that meeting. Each Board member spent a few minutes writing down what they would like to see 6 years from now.

Foundation Members present: Alicia Hays, President; Karen Gaffney, Roger Schaljo, Tim Duncan, Alan Rexius, Chris Achtien. Eric Wold and Marty Daley were unable to attend.

1) Overview of morning session.

For Foundation members Roger discussed the very first Club meeting, what goals were then and what our goals for 2029 are now, and that we worked on committee structures. The Foundation would like to see a list of our committees including goals and responsibilities when the updated versions become available. Roger stated that a good committee structure will help us bring in assistance from Club members in the future.

2) Business Plan.

Alicia requested an update on the Club's business plan. Bob said they are still researching and collecting information as well as looking at how we can add income and how to funnel money to the Foundation.

Karen said that the Foundation is prepared if they get more money than needed for the Regional Facility. Endowments and/or renewable sponsorships would provide ongoing income.

Jeff has been talking to other organizations about how much they charge to run tournaments, and the cost of insurance. He's waiting for further information. Maureen and Karen discussed the usefulness of Pillars of Sustainability (social, environmental and economic).

3) Overview of capital campaign

Alan stated they are currently using Lund Development Solutions as fundraising consultants. Christina has worked on several large projects including the New YMCA and has been very helpful. Timelines per Alan:

committee has prioritized what we want into 20 categories and are working on
getting realistic figures. For example, Jeff has gotten one estimate on solar
panels for 6 million dollars.

6) Discussion of communication between the two Boards and the community.

Jeff would like to see a simple quarterly report from the Foundation on expenses and revenues. Full Foundation minutes including financials are accessible to EVPC Board members on EVPC's google drive.

Chris and Roger will provide monthly updates to the EVPC Board.

The Foundation will develop bullet points for EVPC Club members to know.

As Pickleball explodes we need to include youth and universities in communications.

Jeff said a newsletter could be a possibility.

We should involve Club members as volunteers when there are special events in the community to promote Pickleball.
